#### Moving Toward Value-Based Payment for Medicaid Behavioral Health Service

10:45 am – 12:00 pm

States, health plans, and providers are beginning to develop value-based payment (VBP) arrangements to pay for Medicaid behavioral health care services. VBP approaches shift the focus from traditional fee-for-service systems that pay for volume of services to alternative payment models that reward high-quality, cost-effective care. Many state Medicaid programs have developed VBP approaches to improve quality and slow cost growth for physical health services, but these advances have been slower to emerge in Medicaid behavioral health programs until now.

This session will explore real world examples of implementing a value based arrangement in community behavioral health programs. Attendees will also learn about key challenges in implementing VBP models in behavioral health settings related to quality measurement, provider capacity, oversight considerations, and privacy and data-sharing constraints.

### Organizational Change/Strategic Partnerships: Implementing an Independent Practice Association (IPA)

This partnership of community behavioral health providers and a Medicaid Managed Care Plan will be the first of its kind in the U.S. and much work has went into creating it.

### Medicaid Managed Care for Children in Foster Care: What Are the Challenges and What are the Lessons Learned from Other States

In July 2018, the Department of Children and Family Services (DCFS) is planning to transition its foster care program under a managed care model. Medicaid has been the dominant insurer for children involved in child welfare, and its role was expanded through the ACA. There are over 30 states who have enrolled their foster care system in Medicaid managed care arrangements. It is believed Medicaid Managed care organizations (MCOs) are uniquely positioned to play a key role improving the overall health of these children by emphasizing improvements in the quality and cost of care, the coordination of care, particularly for populations with chronic physical and behavioral health conditions.

This workshop will bring the experience of two national professionals who have witnessed the transition and implementation of a managed care model into the child welfare foster care in other states. Together they will share their respective experience in how planning should be conducted and what needs to be solved if Illinois is going to be successful in improving the outcomes for children in its Child Welfare Foster Care System. A few of the concerns addressed include:

- How to develop working partnerships across child-serving agencies.
- How do we know all the partners are in a “readiness mode” to deliver quality and data driven care?
- How do you develop clinical competencies to serve multi-agency involved children with multiple complex needs?
- The development of meaningful quality measurement for children and families.
- Identify and sustain care coordination capabilities for the foster care population

### Addressing Behavioral Health in Education Through Partnering with Schools and System of Care

Behavioral health conditions present a major challenge for children. It is estimated that as many as one in five children living in the U.S. experience a mental disorder in a given year. Approximately 40% of adolescents experience a mental disorder each year. An estimated 15 million of our nation's young people can currently be diagnosed with mental health disorder. Sadly, it is estimated that only about 7% of the youth who need services receive help from a mental health professional. Untreated mental health conditions distract from learning and school engagement, potentially leading to grade retention, extensive special education needs, school drop-out, or even juvenile justice involvement. Making the case for mental health promotion and prevention in schools can be challenging. Mental or behavioral health services in schools are traditionally thought of in terms of access to individualized treatment, rather than promotion of positive climate for all individuals in the school building. Moreover, mental health is often thought of as the presence or absence of a disease condition rather than a positive asset, or something that can be developed or improved. In this workshop you will hear from three programs from across the state that have developed innovative behavioral health services in partnership with schools to bridge the community-school chasm. These programs are aligned with "The Every Student Succeeds Act (ESSA)" which recognizes the need for schools to support the whole child and specifically acknowledges the importance of student health and wellness, including mental health.

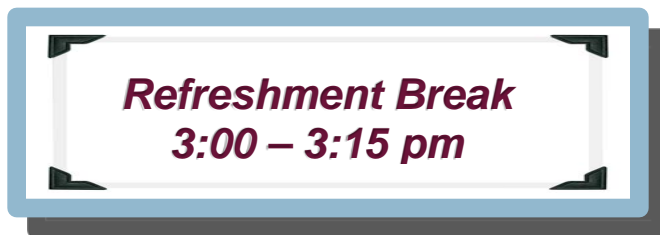
